Annotations to Completed Sample Form 106

Summary of Your Assets and Liabilities and Certain Statistical Information (Official Form 106Sum)

1. This form requests in the identification box the names of both debtors in a joint case, the district where the case is filed, and the case filing number. Identification boxes in other forms filed in the case simply ask for the name of one of the debtors, the debtor who is designated as “Debtor 1.” The case number will not be available if the schedules are filed at the same time as the petition and can be left blank. 2. Official Form 106Sum is a summary of the information provided on the schedules filed by the debtors in the case. It is prepared after the schedules have been completed. [BACK](#)
3. If, after the initial filing, the debtors file any amendments to the schedules or forms that are used to generate the summary, the debtors must fill out a new Form 106Sum and check the box at the top of the form indicating that is an amended filing. [BACK](#)
